COMPENSATION The new employee compensation study was discussed. James Hill made a

Doolan passed the motion with an affirmative vote.

CONSTRUCTION Jeff Humphrey updated the Board on the construction projects that are taking place in the district. AAA Construction will begin the Henderson line replacement project on Monday. He also informed them that a request for bids has been published for the next phase on the meter installation project. The bid closing will be on October 19, 2023.

MANAGER'S REPORT

Jeff Humphrey informed the Board that management attended the Utah Division of Water Resources board meeting and was approved for an additional \$4,743,000 in grant money as well as a loan for \$1,728,000 at an interest rate of 1% to be paid over 15 years. These funds are to be allocated to the secondary water meter project.

Mr. Humphrey also informed the Board that two homes on Polk Street were flooded from the district's secondary water.
